SIGNIFICANT ACCOUNTING POLICIES AND NOTES FORMING AN INTEGRAL PART OF ACCOUNTS FOR THE YEAR ENDED ON 31st MARCH 2020

### A. SIGNIFICANT ACCOUNTING POLICIES

- 1. The accounts are prepared on historical cost basis as a 'Going Concern'. Grants/Donations are accounted for on receipt basis and payments are accounted for on accrual basis except otherwise stated, following generally accepted accounting principles and practices and Accounting Standards issued by the Institute of Chartered Accountants of India for NGOs, wherever applicable.
- 2. Fixed Assets are stated as under:
  - a) Assets directly acquired at purchase cost.
  - b) Assets received in kind at stated / estimated cost.
- 3. The assets acquired are directly charged to expenses and stated in the Balance Sheet through contra entries. Further, no depreciation on fixed assets is provided for, nor claimed as expense.

#### B. NOTES TO ACCOUNTS

- 1. The grants to project partners are directly charged to expenses.
- 2. There are no employees in the organization, hence the provision of Gratuity is not applicable to the organization and accordingly no amount has been provided for the leave encashment.
- 3. There was no addition/ deletion to the fixed assets during the year.
- 4. There is no contingent liability as on 31st March 2020.
